OFFICIAL CALL Mass Meeting of the Scott County Republican Committee of the Republican Party of Virginia

As Chairman of the Scott County Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, John H. Kilgore, Sr., do hereby issue this call for a Mass Meeting to be held at the Scott County Career and Technical Center, 387 Broadwater Avenue, Gate City, Virginia, 24251, starting at 6:00 p.m. local time on Thursday, March 20, 2014 for the following purposes:

- Electing up to two hundred fifteen (215) Delegates and an equal number of Alternates to the Republican Party of Virginia Ninth Congressional District Convention to be held in Wytheville, Virginia at the George Wythe High School, #1 Maroon Drive on Saturday, April 12, 2014 at 10:00 a.m. local time. The purpose of the District Convention is to elect a Congressional District Chairman and to transact such other business as may properly come before the convention. Each unit is entitled to one (1) Delegate Vote per (250) Republican votes for Governor and President at their last election, so that Scott County is entitled to forty three (43) Delegate Votes;
- 2. Electing up to two hundred thirty (230) Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention to be held at the Roanoke Civic Center, 710 Williamson Road, Roanoke, Virginia, 24016 on Saturday, June 7, 2014 at 10:00 a.m. local time. The purpose of the State Convention is to nominate a Republican Candidate for the United States Senate and to transact such other business as may properly come before the convention. Each unit is entitled to one (1) Delegate Vote per (250) Republican votes for Governor and President at their last election, so that Scott County is entitled to forty six (46) Delegate Votes;
- 3. Electing a Scott County Republican unit chairman, two vice chairmen, secretary, treasurer and members to the unit committee;
- 4. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to the above paragraph shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future.

Registration Fees

There will be NO registration fee to participate in this mass meeting. The doors will open for registration at 5:30 pm and end promptly at 6:00 pm. Those individuals in line at 6:00 pm will be allowed to register before the meeting begins.

Delegates and Alternates to the Ninth Congressional District Convention are requested, but not required, to pay a voluntary fee of \$5. Please make checks payable to the Ninth District Republican Committee. Delegates and Alternates to the State Convention are requested, but not required, to pay a voluntary fee of \$35. Please make checks payable to the Republican Party of Virginia.
