

OFFICIAL CALL
Mass Meeting
of the 38th Senate Republican Legislative District Committee
of the Republican Party of Virginia

As Chairman of the 38th Senate Republican Legislative District Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Jack R. Morgan, do hereby issue this call for a Mass Meeting to be held at Nuckolls Hall, Tazewell County Fairgrounds, 515 Fairground Road, Tazewell, VA 24651, starting at 7:00 p.m. (with registration opening at 5:00 p.m.) on Thursday, June 19, 2014, for the following purposes:

- 1) Nominating a Republican Candidate for Member of the Senate of Virginia from the 38th District to be voted upon in the Special Election to be held Tuesday, August 19, 2014;
- 2) And for the transaction of such other business as may properly come before the meeting.

Qualifications for Participation

All legal and qualified voters of the 38th Senate District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the forgoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

Voters may be required to produce personal identification such as a valid driver's license or voter registration card in order to participate in the aforementioned Mass Meeting.

Candidate Filing Requirements for Mass Meeting

Candidates seeking the nomination at the Mass Meeting shall be required to pay a filing fee in the amount of \$720.00 (Seven Hundred and Twenty Dollars) to the Chairman of the 38th Senate Republican Legislative District Committee. Such filing fee must be: a) paid at the Mass Meeting, and b) before or at the time the candidate is nominated from the floor of the Mass Meeting. The filing fee shall be made by check and payable to the 9th Congressional District Republican Committee (place on check memo line "Filing Fee – 38th Senate District) which will serve as the fiscal agent of the 38th Senate Republican Legislative District Committee for this Mass Meeting. Filing fees are non-refundable once remitted.

Registration Fees

There will be no required registration fee to participate in the Mass Meeting.
