

OFFICIAL CALL
Mass Meeting
of the 40th Senate Republican Legislative District Committee
of the Republican Party of Virginia

As Chairman of the 40th Senate Republican Legislative District Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Kevin Corbett, do hereby issue this call for a Mass Meeting to be held at the Scott County Career and Technical Center (former Scott County Vocational School), 387 Broadwater Avenue, Gate City, VA 24251, starting at 6:30 p.m. (with registration opening at 5:30 p.m.) on Monday, May 18th, 2015, for the following purposes:

- 1) Nominating a Republican Candidate for Member of the Senate of Virginia from the 40th District to be voted upon in the General Election to be held Tuesday, November 3, 2015;
- 2) And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of the 40th Senate District under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter. Voters will be required to produce a valid photo identification card in order to participate in the aforementioned Mass Meeting.

Candidate Filing Requirements for Mass Meeting

Candidates seeking the nomination at the Mass Meeting are required to file an official pre-file form by mail or in person to Kevin Corbett, 216 Oakview Drive, Bristol, VA 24201, and also required to pay a filing fee in the amount of \$720.00 (Seven Hundred and Twenty Dollars) to the Chairman of the 40th Senate Republican Legislative District Committee, which must be received no later than 5:00 p.m. on Monday, May 4th, 2015. Postmarks will not govern.

The filing fee shall be made by check and payable to the Bristol Republican Committee (place on check memo line "Filing Fee – 40th Senate District") which will serve as the fiscal agent of the 40th Senate Republican Legislative District Committee for this Mass Meeting. Filing fees are non-refundable once remitted. Forms are available online at www.va9gop.org or www.rpv.org or by calling 276.466.8950. Only those whom have pre-filed will be considered for nomination at the Mass Meeting. No other nominations from the floor will be in order.

Registration Fees

There will be no required registration fee for individuals participating in the Mass Meeting.
