

OFFICIAL CALL
Mass Meeting
of Craig County
of the Republican Party of Virginia

As Chairman of the Craig County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Don Bishop, do hereby issue this call for a Mass Meeting to be held at Craig County Courthouse, Main Street, New Castle, Va., starting at 1:00 p.m. local time on March 31, 2012 for the following purposes:

1. Electing up to 55 Delegates and an equal number of Alternates to the Republican Party of Virginia 9th District Convention to be held in George Wythe High School, #1 Maroon Way, Wytheville, Virginia on Saturday April 28, 2012 at 10:00 a.m. for the purposes of electing a District Chairman, three Delegates and three Alternate Delegates to the RNC Convention, a Presidential Elector, and electing three (3) members to the State Central committee. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Craig County is entitled to 11 Delegate Votes.
2. Electing up to 55 Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention, to be held on June 16, 2012 at the Greater Richmond Convention Center, beginning at 10 a.m. for the purposes of electing a State Party Chairman, RNC National Committeeman, RNC National Committeewoman, 13 At-Large Delegates and 13 At-Large Alternate Delegates to the RNC Convention, and two At-Large Presidential Electors. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Craig County is entitled to 11 Delegate Votes.
3. To elect a unit chairman, vice-chairman, treasurer, secretary and members to the unit committee;

And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for election for Unit Chairman, as a delegate or alternate delegate to the 9th District Convention, or the State Convention, at said mass meeting shall file a written statement by mail or in person, to Don Bishop, 6625 Craig Valley Dr., New Castle, Va. 24127, which must be received not later than 6:00 p.m. March 29, 2012. Postmarks do not govern.

If fewer than the maximum number of Delegates that Craig County is entitled to at the 9th District convention prefile, all properly prefiled candidates shall be deemed elected. If no more than one candidate files for election to any office to be voted upon at the mass meetings, that candidate will be declared elected.

There is no registration fee to participate in this mass meeting.
