Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that the Committee is entitled to 26 Delegate Votes;

## **Qualifications for Participation**

All legal and qualified voters of Dickenson under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

**Registration Fee** 

There will be NO registration fee to participate in this Mass Meeting
