Mass Meeting Of the Henry County Committee Of the Republican Party of Virginia

As Chairman of the Henry County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, W. C. Fowlkes, do hereby issue this call for a Mass Meeting to be held at 3300 Kings Mountain Road, Martinsville, VA 24112 starting at 7:00 p.m. local time on March 12, 2013 for the following purpose:

- A. Electing up to <u>445 Delegates</u> and an equal number of Alternates to the Republican Party of Virginia's State Convention, to be held on Friday May 17th and Saturday May 18th, 2013 at the Richmond Coliseum located at 601 East Leigh Street, Richmond, Virginia beginning at 2:00 PM local time on Friday May 17th [No voting for candidates for the office of Governor, Lt. Governor or Attorney General will be conducted prior to 12:00PM local time on Saturday May 18, 2013] for the purposes of nominating a **Republican candidate for Governor**, Lt. Governor, and Attorney General. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Henry County is entitled to 89 Delegate Votes;
- B. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Henry County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. Photo ID or Voter Registration Card required. Proxies do no apply.

Filing Requirements

Candidates for election as Delegates and Alternate Delegates to the 2013 Republican Party of Virginia State Convention shall submit the completed State Convention Pre-File Form by mail or in person, to W. C. Fowlkes, at 99 Stonewall Jackson Trail, Martinsville, VA 24112 or, P. O. Box 3458, Martinsville, VA 24115, which must be received not later than 5:00 p.m. on March 5, 2013. Postmarks will not govern. The filing form may be requested from W. C. Fowlkes, at 276-632-3251, or email at <u>wcfowlkes@comcast.net</u>, or online at <u>www.RPV.org</u>. If fewer candidates file for Delegates than spaces available, all properly filed Delegates shall be deemed elected and the Mass Meeting will be cancelled.
