

OFFICIAL CALL

Mass Meeting

of the Henry County Republican Committee

of the Republican Party of Virginia

As Chairman of the Henry County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, W.C. Fowlkes, do hereby issue this call for a Mass Meeting to be held at the Henry County Administration Building, 3160 Kings Mountain Road, Martinsville, Virginia, 24112, with registration to begin at 6:00 PM local time and the meeting to begin promptly at 7:00 PM local time on Tuesday, April 10, 2012 for the following purposes:

a) Electing a Unit Chairman;

b) Electing members of the Unit Committee;

c) Electing up to 440 Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention, to be held on June 16, 2012, at the Greater Richmond Convention Center, 403 North Third Street, Richmond City, starting at 10:00 A.M., for the purposes of electing a State Party Chairman, an RNC National Committeeman, and an RNC National Committeewoman; nominating two Presidential Electors; and electing 13 At-Large Delegates and 13 At-Large Alternate Delegates to the Republican National Convention, to be held beginning on August 27, 2012 at Tampa, Florida, or its alternate site, for the purpose of nominating candidates for President and Vice-President of the United States. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Henry County is entitled to 88 Delegate Votes;

d) Electing up to 55 Delegates and an equal number of Alternates to the **Fifth Congressional District Convention**, to be held on Saturday, May 19, 2012 at Hampden-Sydney College, John's Auditorium, 80 College Road, Hampden-Sydney, Virginia, 23943, beginning at 11:00 A.M. with registration from 9:30 A.M., for the purposes of electing a District Chairman and three members of the State Central Committee; nominating a Presidential Elector; and electing three Delegates and three Alternates to the Republican National Convention. Each unit is entitled to one (1) Delegate Vote per 500 Republican votes for Governor and President at their last election, so that **Henry County is entitled to 11 Delegate Votes**;

e) Electing up to 330 Delegates and an equal number of Alternates to the **Ninth Congressional District Convention**, to be held on Saturday, April 28, 2012 at George Wythe High School, #1 Maroon Way, Wytheville, Virginia, 24382, beginning at 10:00 A.M. with registration from 8:00 A.M., for the purposes of electing a District Chairman and three members of the State Central Committee; nominating a Presidential Elector; and electing three Delegates and three Alternates to the Republican National Convention. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that **Henry County is entitled to 66 Delegate Votes**;

f) and for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Henry County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. Voters may be required to produce personal identification such as a valid driver's license or voter registration card.

Registration Fees

There will be a voluntary \$5 registration fee to participate in this mass meeting. There are *mandatory* membership dues of \$10 to be a member of the Henry County Republican Committee. **There will be a voluntary \$10 registration fee to participate in the 5th District Convention. There will be a voluntary \$5 registration fee to participate in the 9th District Convention. There will be a voluntary \$35 registration fee to participate in the State Convention.**

Voluntary fees and mandatory fees are requested to be paid at the time of filing for election as Delegate for each respective convention, payable to the **Henry County Republican Committee**, except for the State Convention fee, which is payable to the **Republican Party of Virginia**.
