

OFFICIAL CALL
Mass Meeting of the Lee County Republican Committee
of the Republican Party of Virginia

As Chairman of the Lee County Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Roger Elkins, do hereby issue this call for a Mass Meeting to be held at the Lee County Circuit Court Courtroom, Main and Church Streets, Jonesville, Virginia 24263 or its alternative site, starting at 7:00 p.m. local time on March 22, 2012 for the following purposes:

- a) Electing a Lee County Republican Committee Chairperson;
- b) Electing Officers of the Lee County Republican Committee as follows: Vice-Chairperson, Secretary and Treasurer;
- c) Electing up to 38 Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention, to be held on June 16, 2012 at the Greater Richmond Convention Center, beginning at 10 a.m. for the purposes of electing a State Party Chairman, RNC National Committeeman, RNC National Committeewoman, 13 At-Large Delegates and 13 At-Large Alternate Delegates to the RNC Convention, and two At-Large Presidential Electors. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that the Lee County Republican Committee is entitled to 38 Delegate Votes;
- d) Electing up to 38 Delegates and an equal number of Alternates to the Ninth Congressional District Republican Committee Convention, to be held on April 28, 2012 at George Wythe High School, #1 Maroon Way, Wytheville, Virginia, 24382, or its alternative site, beginning at 10:00 a.m. for the purposes of electing a District Chairman, three Delegates and three Alternate Delegates to the RNC Convention, a Presidential Elector, and electing 3 members to the RPV State Central Committee. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that the Lee County Republican Committee is entitled to 38 Delegate Votes;
- e) and for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Lee County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Registration Fee

There will be no registration fee to participate in this mass meeting. However, there is a voluntary fee of \$5.00 for every person elected as a delegate or alternate to the Ninth District Republican Convention. There is a voluntary fee of \$35.00 for every person elected as a delegate or alternate to the 2012 State Convention. Voluntary fees are requested to be paid at the time of filing for election as a Delegate for each respective convention, payable to the Lee County Republican Committee.
