

Official Call
Mass Meeting
Montgomery County Republican Committee

As Chairman of the Montgomery County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, David Nutter, do hereby issue this call for a party mass meeting to be held at the Montgomery County Government Center, 755 Roanoke Street, Christiansburg, Va. 24073, starting at 7 p.m. local time on Thursday, March 13, 2014, with registration beginning at 6:30 pm and ending at 7:15 pm, for the following purposes:

- 1.) Electing a unit chairman;
- 2.) Electing members of the unit committee;
- 3.) Electing up to 605 Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention to be held on Saturday, June 7, 2014 at the Roanoke Civic Center, 710 Williamson Road, Roanoke, Virginia 24016 or its alternate site, beginning at 10 am local time for the purpose of nominating a Republican candidate for the United States Senate and for the transaction of such other business as may properly come before the convention;
- 4.) Electing up to 570 Delegates and an equal number of Alternates to the 9th District Convention to be held on Saturday, April 12, 2014 at the George Wythe High School, #1 Maroon Way, Wytheville, Virginia beginning at 10 am for the purpose of electing a 9th District Chairman and for the transaction of such other business as may properly come before the convention;
- 5.) No resolutions shall be permitted from the floor;
- 6.) No nominations (for office) shall be permitted from the floor;
- 7.) And for the transaction of such business as may properly come before the mass meeting.

In the event of inclement weather on March 13, the mass meeting will be held the following Thursday, March 20 at 7 p.m at the Montgomery County Government Center. All pre-filing deadlines as outlined above remain the same.

Qualification for Participation

All legal and qualified voters of Montgomery County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise

qualified hereunder shall not have participated in Virginia in the nominating process of another party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominee of the Republican Party in the future. Any voter that utilizes the forgoing exception, and thereafter participates in the nominating process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

Filing Requirements

- 1.) Unit Chairman of the Montgomery Committee – Candidates for the position of Unit Chairman shall file a written statement of their candidacy by mail to or in person to David Nutter, 2729 Old Fort Road, Blacksburg, VA 24060 which must be received no later than 5 p.m. Thursday, March 6, 2014. Postmarks do not govern.
- 2.) Candidates for election as Delegate or Alternate to the Republican Party of Virginia State Convention or Ninth District Convention, must pre-file a written statement of their intent on a form provided by the Unit Committee to the Montgomery County Republican Committee, P.O. Box 997, Christiansburg, Va. 24068 which must be received no later than 5 pm March 11, 2014 or attend the Mass Meeting. Postmarks do not govern. The pre-filing form can be obtained by contacting David Nutter at (540) 230-8015 or online at www.rpv.org or at www.montvagop.org.
- 3.) Candidates for membership in the Montgomery County Republican Committee need to submit a written statement of their intent to join the unit committee on a form provided by the Unit Committee to the Montgomery County Republican Committee, P.O. Box 997, Christiansburg, Va. 24068 which must be received no later than 5 pm March 11, 2014. A mandatory \$20 filing fee is required.

Registration Fees and Additional Information

There is no fee to participate in the Mass Meeting. There is a voluntary registration fee of \$35 to participate in the Republican State Convention and should be submitted with Delegate/ Alternate filing form. There is \$5 voluntary participation fee to participate in the 9th District Convention which can be submitted with the filing form or paid at the convention during registration.
