Mass Meeting of Patrick County Committee of the Republican Party of Virginia

As Chairman of the Patrick County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Larry A. Stanley, do hereby issue this call for a Mass Meeting to be held at SureStop Store Building at 4709 Claudville Highway, Claudville, VA 24076, starting at 10 a.m. local time on Saturday, March 29, 2014 for the following purposes:

- A. Electing a Chairman for the Patrick County Republican Committee
- B. Election the members of the Patrick County Republican Committee
- C. Electing up to 170 Delegates and an equal number of Alternates to the Republican Party of Virginia's 9th District Convention, to be held on Saturday, April 12, 2014 at the George Wythe High School, 1 Maroon Way, Wytheville, VA 24382 or its alternate site, beginning at 10 a.m. local time for the following purposes:
 - a. Nominating a Republican candidate for the United States House of Representatives (if necessary)
 - b. Electing a Chairman for the 9th Congressional District Republican Committee
 - c. And for the transaction of such other business as may properly come before the convention

The Committee is entitled to 34 Delegate Votes at the District Convention

- D. Electing up to 185 Delegates and an equal number of Alternates to the Republican Party of Virginia's State Convention, to be held on Saturday, June 7, 2014 at the Roanoke Civic Center, 710 Williamson Road, Roanoke, Virginia 24016 or its alternate site, beginning at 10:00 a.m. local time for the following purposes:
 - a. Nominating a Republican candidate for the United States Senate
 - b. And for the transaction of such other business as may properly come before the convention

Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that the Committee is entitled to 37 Delegate Votes;

E. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Patrick County (LOCALITY) under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either

orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for the election at said mass meeting shall file a written statement by mail or in person, to Larry Stanley, Chairman, P.O. Box 187, Claudville, VA 24076, which must be received not later than 10 a.m on March 29, 2014. Postmarks will not govern. The filing form can be picked up from Larry Stanley, Chairman and online at www.RPV.org. If fewer candidates file for Delegates than spaces available, all properly filed Delegates will be deemed elected and the Mass Meeting will be canceled.

Registration Fee

The Republican Party of Virginia is requesting a voluntary \$35 filing fee from all individuals seeking election as a Delegate to the State Convention.
