## OFFICIAL CALL Mass Meeting of Patrick County of the Republican Party of Virginia

As Chairman of the Patrick County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Alex Stanley, do hereby issue this call for a Mass Meeting to be held at Dry Pond Community Building, 2130 Dry Pond Highway, Stuart, Virginia, 24171, starting at 7:00pm local time on April 12<sup>th</sup>, 2012 for the following purposes:

a) Electing a Unit Chairman, Vice-Chairman, Treasurer, and Secretary;

b) Electing members of the Patrick County Republican Committee;

c) Electing up to 175 Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention, to be held on June 16 at the Greater Richmond Convention Center, 403 North Third Street, Richmond VA, beginning at 10am. The purpose of the state convention is to elect a State Chairman, nominate a National Committeeman and Committeewoman, nominate two at-Large Presidential Electors, and elect 13 delegates and 13 alternates to the 2012 Republican National Convention to be held beginning on August 27, 2012 at the St. Petersburg Times Forum –Tampa, Florida, or its alternate site, for the purpose of nominating candidates for President and Vice President of the United States. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Patrick County is entitled to 35 Delegate Votes;

d) Electing up to 175 Delegates and an equal number of Alternates to the 9<sup>th</sup> District Republican Convention, to be held on April 28 at George Wythe High School, #1 Maroon Way, Wytheville, VA, beginning at 10:00am for the purposes of electing a District Chairman, three members of the State Central Committee, three Delegates and three Alternate Delegates to the RNC Convention, a Presidential Elector, and for the transaction of such other business as may properly come before the convention. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Patrick County is entitled to 35 Delegate Votes;

e) and for the transaction of such other business as may properly come before the mass meeting.

## **Qualifications for Participation**

All legal and qualified voters of Patrick County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

## **Registration Fee**

There will be no registration fee to participate in the Patrick County Republican Committee mass meeting.

A voluntary registration fee of Thirty-Five Dollars (\$35.00) (for the Republican Party of Virginia) is requested of each delegate or alternate delegate to the State Convention.

Delegates and Alternates to the 9th Congressional District Convention are requested, but not required, to pay a voluntary fee of \$5.
