

OFFICIAL CALL
Mass Meeting of Pulaski County Republican Committee

As Chairman of the Pulaski County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Angie Marshall Hall, do hereby issue this call for a Mass Meeting to be held at the Pulaski County Courthouse, 45 Third Street NW, Pulaski, VA 24301, in the General District Courtroom starting at 7:00 PM local time on Tuesday, March 25, 2014 for the following purposes:

1. Electing a Chairman for the Pulaski County Republican Committee;
2. Electing the members of the Pulaski County Republican Committee;
3. Electing up to two-hundred seventy-five (275) Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention to be held on Saturday, June 7, 2014 at the Roanoke Civic Center, 710 Williamson Road, Roanoke, VA 24016 or its alternate site, beginning at 10:00 AM local time for the following purposes:
 - a) Nominating a Republican candidate for the United States Senate;
 - b) And for the transaction of such other business as may properly come before the convention;
4. Electing up to two-hundred sixty (260) Delegates and an equal number of Alternates to the Republican Party of Virginia 9th Congressional District Convention to be held on Saturday, April 12, 2014 at the George Wythe High School, 1 Maroon Way, Wytheville, VA 24382 or its alternative site, beginning at 10:00 AM local time for the following purposes:
 - a) Electing a Chairman of the 9th Congressional District Republican Committee;
 - b) And for the transaction of such other business as may properly come before the convention;
5. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Pulaski County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts. In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party in the last five years. A single exception to the above shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. A voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a Party other than the Republican Party, shall not have the benefit of the exception as identified in this paragraph thereafter.

In order to be eligible for election as a Delegate or Alternate Delegate to any convention, an individual must be registered to vote no later than the pre-filing deadline established by the Official Committee or, if pre-filing is not a requirement, no later than the date of election as a Delegate. A person who has made application for registration and meets all other requirements herein, but whose name does not appear on the local registration books solely because of the books having been closed in connection with a local election, will nevertheless be deemed a legal and qualified voter.

Filing Requirements

Candidates for election of the Pulaski County Unit Chairman shall file a written statement of their candidacy. All forms must be received by Tuesday, March 18, 2014, 5:00 PM, in person or by mail (postmarks do not govern) to the following address:

Candidates for election to membership in the Pulaski County Committee, Delegates and Alternates to the April 12th District Convention and/or the June 7th State Convention shall file a written statement of intent to the Committee Chairman, Angie Marshall Hall, stating their intent to join the unit committee and/or attend the 9th Congressional District Convention and/or the RPV State Convention using the pre-file form provided by the Committee for this purpose. All forms must be received by March 25, 2014, 7:00 PM local time either in person or by mail (postmarks do not govern) to the Chairman at the following address:

There is a \$5 voluntary registration fee to participate in the 9th District Convention, which may be paid at with the Pulaski County Committee Mass Meeting filing form or at the 9th District Convention registration.
