

OFFICIAL CALL

Mass Meeting of the **Pulaski County** Republican Party Of the Republican Party of Virginia

As Chairman of the **Pulaski County** Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Jean F. Evans, do hereby issue this call for a Mass Meeting to be held at the **Pulaski County Courthouse, 45 Third Street, NW, Pulaski, VA**, starting at 7:00 P.M. on **Monday March 19, 2012**, for the following purposes:

- a) electing a Unit Chairman;
- b) electing members of the Unit Committee;
- c) electing up to 58 Delegates and 58 Alternates to the Republican Party of Virginia State Convention, to be held on June 16, 2012 at the Greater Richmond Convention Center, 403 North Third Street, Richmond City, beginning at 10:00 a.m. for the purposes of electing a State Party Chairman, RNC National Committeeman, RNC National Committeewoman, 13 At-Large Delegates and 13 At-Large Alternate Delegates to the RNC Convention, and two At-Large Presidential Electors. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Pulaski County Republican Party is entitled to 58 Delegate votes;
- d) electing up to 58 Delegates and 58 Alternates to the 9th Congressional District Convention to be held on Saturday, April 28, 2012 at George Wythe High School, #1 Maroon Way, Wytheville, VA 24382, beginning at 10:00 A.M. for the purposes of electing a District Chairman, three members of the State Central Committee, three Delegates and three Alternate Delegates to the RNC National Convention to be held at the St. Petersburg Times Forum in Tampa Florida or its alternate site from August 27 to August 30, 2012, a Presidential Elector from the 9th Congressional District of Virginia to serve in the 2012 Electoral College;
- e) and for the transaction of such other business as may properly come before the Mass Meeting.

Qualifications for Participation: All legal and qualified voters of Pulaski County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required their intent to support all of its nominees for public office in the ensuing election may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

Voters may be required to produce personal identification such as a valid driver's license or voter registration card.

Registration Fee: There will be no registration fee to participate in the mass meeting. There is a voluntary registration fee of \$35 for the State Convention and a voluntary registration of \$5 for the 9th District Convention. Voluntary fees are requested to be paid at the time of filing for election as a Delegate for each respective convention, payable to the **Pulaski County** Republican Committee.
