

OFFICIAL CALL  
Mass Meeting  
of the Scott County Republican Committee  
of the Republican Party of Virginia

As Chairman of the Scott County Republican Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, John H. Kilgore, Sr., do hereby issue this call for a Mass Meeting to be held at the Scott County Circuit Courtroom, 202 West Jackson Street, Gate City, Virginia, 24251, starting at 6:00 p.m. local time on Thursday, March 29, 2012 for the following purposes:

1. Electing up to two hundred twenty five (225) Delegates and an equal number of Alternates to the Republican Party of Virginia Ninth Congressional District Convention to be held in Wytheville, Virginia at the George Wythe High School, #1 Maroon Drive on Saturday, April 28, 2012 at 10:00 a.m. local time. The purposes of the District Convention are to elect a Congressional District Chairman, elect three (3) members to State Central Committee, elect three (3) delegates and three (3) alternates to the 2012 Republican National Convention at the St. Petersburg Times Forum in Tampa, Florida, August 27 -30, nominate one (1) Elector to serve in the 2012 Electoral College and to transact such other business as may properly come before the convention. Each unit is entitled to one (1) Delegate Vote per (250) Republican votes for Governor and President at their last election, so that Scott County is entitled to forty five (45) Delegate Votes;
2. Electing up to two hundred twenty five (225) Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention to be held at the Greater Richmond Convention Center, 403 North Third Street, Richmond, Virginia on Saturday, June 16, 2012 at 10:00 a.m. local time. The purposes of the State Convention are to elect a State Chairman, elect thirteen (13) at large delegates and thirteen (13) at large alternates to the 2012 Republican National Convention at the St. Petersburg Times Forum in Tampa Florida, August 27 -30, nominate two (2) Electors at large to serve in the 2012 Electoral College, nominate a National Committeeman and National Committeewoman and to transact such other business as may properly come before the convention. Each unit is entitled to one (1) Delegate Vote per (250) Republican votes for Governor and President at their last election, so that Scott County is entitled to 45 Delegate Votes;
3. Electing a Scott County Republican unit chairman, two vice chairmen, secretary, treasurer and members to the unit committee;
4. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

### Registration Fees

There will be no registration fee to participate in this mass meeting. Delegates and Alternates to the Ninth Congressional District Convention are requested, but not required, to pay a voluntary fee of \$5. Please make checks payable to the Ninth District Republican Committee. Delegates and Alternates to the State Convention are requested, but not required, to pay a voluntary fee of \$35. Please make checks payable to the Republican Party of Virginia.
