

OFFICIAL CALL  
Mass Meetings of Montgomery County Unit Committee  
of the Republican Party of Virginia

As Chairman of the Montgomery County Unit Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Marcy Hernick, do hereby issue this call for a Mass Meeting to be held at the Government Center, 755 Roanoke St., Christiansburg, VA 24073 at 10:00 AM local time on March 23 for the following purposes:

- A. Electing up to 630 Delegates and an equal number of Alternates to the Republican Party of Virginia's State Convention, to be held on Friday May 17<sup>th</sup> and Saturday May 18<sup>th</sup>, 2013 at the Richmond Coliseum located at 601 East Leigh Street, Richmond, Virginia beginning at 2:00 PM local time on Friday May 17<sup>th</sup> [No voting for candidates for the office of Governor, Lt. Governor or Attorney General will be conducted prior to 12:00PM local time on Saturday May 18, 2013] for the purposes of nominating a Republican candidate for Governor, Lt. Governor, and Attorney General. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Montgomery County is entitled to 126 Delegate Votes;
- B. And for the transaction of such other business as may properly come before the mass meeting

Qualifications for Participation

All legal and qualified voters under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party, and who, if requested, express in open meeting either orally or in writing as may be required their intent to support all of its nominees for public office in the ensuing election may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions, or primaries encompassing their respective election districts.

Each person offering to vote shall present a government issued photographic identification or an official Commonwealth of Virginia Voter Registration card issued by the Montgomery County Registrar.

Registration

Registration shall open at 8:30 a.m. local time and shall conclude at 10 a.m. local time. The Mass Meeting shall be called to order at 10 a.m. local time.

Filing Requirements

Candidates for election as a delegate or alternate delegate to the Republican Party of Virginia State Convention at said mass meeting shall file in advance a Delegate Filing Form, provided by the Montgomery County Unit Committee. The Delegate Filing Form must be delivered by mail or in person to: Marcy Hernick, 2673 Blossom Trail East, Blacksburg, VA 24060 by no later than March 13 at 6:00 p.m. local time. Postmarks do not govern.

Prefiling/Registration Fees

There will be no registration fee to participate in this Mass Meeting.

The Republican Party of Virginia is requesting a voluntary \$35 filing fee from all individuals seeking election as a Delegate to the State Convention. Checks need to be made out to the "Republican Party of Virginia".
