OFFICIAL CALL

Mass Meeting of the Salem Committee of the Republican Party of Virginia

As Chairman of the Salem Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Kjersten Croke, do hereby issue this call for a Mass Meeting to be held at the Salem Civic Center (Parlor A), 1001 Roanoke Blvd, Salem, VA 24153 starting at 6:30 p.m. local time on Thursday, April 25, 2013 for the following purpose:

- A. Electing up to 240 Delegates and an equal number of Alternates to the Republican Party of Virginia's State Convention, to be held on Friday May 17th and Saturday May 18th, 2013 at the Richmond Coliseum located at 601 East Leigh Street, Richmond, Virginia beginning at 2:00 PM local time on Friday May 17th [No voting for candidates for the office of Governor, Lt. Governor or Attorney General will be conducted prior to 12:00PM local time on Saturday May 18, 2013 for the purposes of nominating a Republican candidate for Governor, Lt. Governor, and Attorney General. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Salem is entitled to 48 Delegate Votes;
- B. Selecting a Republican nominee for the office of Commonwealth's Attorney, Sheriff, Commissioner of the Revenue and Treasurer to be voted on in the General Election on November 5, 2013
- C. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Salem under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for the election at said mass meeting shall file a written statement by mail or in person, to Kjersten Croke at 113 Keesling Ave., Salem VA 24153, which must be received not later than 6:00 p.m. on Wednesday, April 17, 2013. Postmarks will not govern. The filing form can be picked up from Kjersten Croke, at 113 Keesling Avenue, Salem VA 24153 and online at www.salemrepublicans.com. Candidates for the Republican nomination for the office of Commonwealth's Attorney, Sheriff, Commissioner of the Revenue and Treasurer at said Mass Meeting shall file a written statement by mail or in person, to Kjersten Croke, 113 Keesling Avenue, Salem VA 24153, which must be received not later than 6:00 PM April 1, 2013. This statement must be accompanied by a \$500.00 filing fee on a check made payable to the Salem Republican Committee and an affirmative declaration of their intent to support the Republican Party's nominee in the November 5th, 2013 Election. Postmarks do not govern. Candidates must meet with the Executive Committee prior to filing a written statement and fees. To arrange for a meeting, contact Kjersten Croke at 540-588-3625.

Each person offering to vote shall present a government issued photographic identification or an official Commonwealth of Virginia Voter Registration card issued by the Salem City Registrar.

The Republican Party of Virginia is requesting a voluntary \$35 filing fee from all individuals seeking election as a Delegate to the State Convention. Checks need to be made out to the "Republican Party of Virginia".

Constitutional Officers (Commonwealth's Attorney, Sheriff, Commissioner of the Revenue and Treasurer) – \$500 pre-filing fee.
