

OFFICIAL CALL

Mass Meeting of the Tazewell County Committee of the Republican Party of Virginia

As Chairman of the Tazewell County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Aaron Roberts, do hereby issue this call for a Mass Meeting to be held at 108 E. Main Street, Tazewell, VA 24651 starting at 9:00 A.M. local time on Saturday, April 27, 2013 for the following purposes:

- A. Electing up to 430 Delegates and an equal number of Alternates to the Republican Party of Virginia's State Convention, to be held on Friday May 17th and Saturday May 18th, 2013 at the Richmond Coliseum located at 601 East Leigh Street, Richmond, Virginia beginning at 2:00 PM local time on Friday May 17th for the purposes of nominating a Republican candidate for Governor, Lt. Governor, and Attorney General. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Tazewell County is entitled to 86 Delegate Votes;
- B. Nominating Candidates for Board of Supervisors for the Northern, Western, and Southern Magisterial Districts of Tazewell County to be voted on in the General Election on November 5, 2013.
- C. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Tazewell County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for state convention delegate and candidates for nomination for the Board of Supervisors at said mass meeting shall file a completed form by postal mail, in person, or by e-mail (scanned copy), with Aaron Roberts, P.O. Completed forms must be received not later than 6 p.m., Wednesday, April 24, 2013. Postmarks will not govern. Official filing forms may be picked up from one of the above individuals and are also available online at www.RPV.org or www.tazgop.net. If no more than one candidate for Board of Supervisors files in any District, that candidate will be declared the Republican nominee. If not more than the number of persons to be elected shall file as a candidate for state convention delegate, then all qualified and properly filed persons shall be deemed elected.

Registration Fee

The Republican Party of Virginia is requesting a **voluntary** \$35 filing fee from all individuals elected as a Delegate to the State Convention. Checks should be made out to the "Republican Party of Virginia". A **voluntary** registration contribution of \$5.00 to defer the expenses of the mass meeting is requested from the Tazewell County Republican Committee.
