### OFFICIAL CALL

# Mass Meeting of the Radford City Republican Committee of the Republican Party of Virginia

As Chairman of the Radford City Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, John N. Dalton, Jr., do hereby issue this call for a Mass Meeting to be held at the Radford City Municipal Building, 619 Second Street, Radford, VA 24141, starting at 1:00 p.m. local time on April 27, 2013 for the following purposes:

- A. Electing up to 80 Delegates and an equal number of Alternates to the Republican Party of Virginia's State Convention, to be held on Friday May 17<sup>th</sup> and Saturday May 18<sup>th</sup>, 2013 at the Richmond Coliseum, located at 601 East Leigh Street, Richmond, Virginia, beginning at 2:00 PM local time on Friday, May 17<sup>th</sup> [No voting for candidates for the office of Governor, Lt. Governor or Attorney General will be conducted prior to 12:00 PM local time on Saturday May 18, 2013] for the purposes of Nominating a Republican candidate for Governor, Lieutenant Governor and Attorney General. Each unit is entitled to one (1) Delegate Vote per 250 Republican votes for Governor and President at their last election, so that Radford City is entitled to 16 Delegate Votes;
- B. Nominating a Republican candidate for the City of Radford Commonwealth's Attorney, City Treasurer, Commissioner of Revenue, and Sheriff to be voted upon in the November 5, 2013 General Election;
- C. And for the transaction of such other business as may properly come before the mass meeting.

## Qualifications for Participation

All legal and qualified voters of the City of Radford under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

#### Filing Requirements

Candidates for the election at said mass meeting and candidates seeking the Republican nomination for a constitutional office, shall file a written statement by mail or in person, to John N. Dalton, Jr, Chairman at 724 West Main Street, Radford, Virginia 24141,

which must be received not later than 5:00 PM on April 19, 2013. Postmarks will not govern. The filing forms can be picked up from John N. Dalton, Jr, Chairman at 724 West Main Street, Radford, Virginia 24141 and online at <a href="www.RPV.org">www.RPV.org</a>. Only those whom have pre-filed will be considered for nomination and/or election at the Mass Meeting. If fewer candidates file for Delegates than spaces available, all properly filed Delegates will be deemed elected and the Delegate election part of the Mass Meeting will be canceled.

## Registration Fee

The Republican Party of Virginia is requesting a voluntary \$35 filing fee from all individuals seeking election as a Delegate to the State Convention. Checks need to be made out to the "Republican Party of Virginia".
