OFFICIAL CALL

Mass Meeting of Bristol City Republican Committee of the Republican Party of Virginia

As Chairman of Bristol Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Kevin Corbett, do hereby issue this call for a Mass Meeting to be held on Monday, May 19th, 2014 at 7:00 p.m. at the Bristol Courthouse, General District Courtroom, 497 Cumberland Street, Bristol, VA starting at 7:00 p.m. local time, with registration opening at 6:30 p.m. local time for the following purposes:

- A) Nominating a Republican candidate for Clerk of the Circuit Court of the City of Bristol to be voted upon in the Special Election on November 4, 2014
- B) And for the transaction of other business which may properly come before the Mass Meeting.

Qualifications for Participation

All legal and qualified voters of the City of Bristol under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Voters may be required to produce personal identification such as a driver's license or voter registration card in order to participate in the mass meeting or convention. The Mass Meeting will begin promptly at 7:00 p.m. with registration closing shortly thereafter.

In addition to the foregoing, to be accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

Filing Requirements

Individuals seeking the Republican nomination for Clerk of the Circuit Court shall be required to pre-file a written statement of their intent on a form provided by the Committee to the Bristol Republican Committee, 216 Oakview Drive, Bristol, Virginia 24201 or by physical delivery to Chairman Kevin Corbett which must be received no later than 5:00 p.m. on Friday, May 12th, 2014. Forms are available online at www.va9gop.org or by calling 276.466.8950. Postmarks do not govern. Only those whom have pre-filed will be considered for nomination at the Mass Meeting. No other nominations from the floor will be in order. Pre-filed candidates may be required to meet with committee representatives prior to the Mass Meeting date.

Registration Fee

There will be no registration or candidate filing fees to participate in the Mass Meeting. Voluntary contributions to defray the cost of the meeting will be accepted.
