OFFICIAL CALL

MASS MEETING OF THE WISE COUNTY/CITY OF NORTON COMMITTEE OF THE REPUBLICAN PARTY OF VIRGINIA

As Chairman of the Wise County Committee of the Republican Party of Virginia, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Kimberly Mullins, do hereby issue this joint call for a Mass Meeting, along with Suzanna Mullins, Chairman of the City of Norton, to be held at the Campus of The University of Virginia's College at Wise,1 College Avenue, Wise Virginia, in Cantrell Hall, starting at 7:00PM local time on June 2, 2015 for the following purpose:

Selecting a Republican nominee, shared by Wise County and the City of Norton, for each of the offices of Sheriff, Clerk of the Court, and Commonwealth's Attorney. Selecting a Republican nominee in Wise County for each of the offices of Commissioner of Revenue, Treasurer, Board of Supervisors for District 1, 2, 3, and 4 to be voted on in the General Election on November 3, 2015.

QUALIFICATIONS

All legal and qualified voters of Wise County and the City of Norton under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meeting, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that

he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the forgoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

FILING REQUIREMENTS

Candidates for the election at said mass meeting shall file the pre-file form by mail or in person, to Kimberly Mullins at P. O. Box 970, Norton, VA 24273 or 538 Park Ave SW, Norton Virginia, which must be received no later than 5:00PM on Tuesday, May 5, 2015. If mailed postmarks will not govern. The filing form can be picked up from Kimberly Mullins at 538 Park Ave SW in Norton and online at www.va9gop.org. The filing fee for Board of Supervisors is \$100.00 made payable to the Wise County Republican Party. The filing fee for the Constitutional offices is \$500.00 made payable to the Wise County Republican Party. For more information regarding this Call, contact Kimberly Mullins at 276-275-7388.

REGISTRATION AND FEES

There will be no registration fee to participate in the mass meeting.

The registration will begin at 6:00PM and end at 7:00PM. Those people in line at 7:00PM will be duly registered to vote before the meeting begins. Please bring a picture ID to pick up your credentials to be able to vote. It would be preferable to also bring your voter registration card to expedite the registration process.

VOTING

All candidates will be elected by a majority vote. If there are 3 or more candidates for the same office and no one has a majority, the candidate with the lowest vote will drop out and a second ballot will be taken. If there is only one candidate for an office, then they must receive a majority vote to be the nominee for that office.

Candidates for the offices of Sheriff, Clerk of the Court, and Commonwealth's Attorney will be voted on by all qualified voters in Wise County and the City of Norton. Candidates for the offices of Treasurer and Commissioner of Revenue will be voted on by all qualified voters in Wise County. Candidates for Board of Supervisors will be voted on by all qualified voters in their respective districts.
