

OFFICIAL CALL

Mass Meeting of the Pulaski County Republican Committee of the Republican Party of Virginia

As chairman of the Pulaski County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Angie Marshall Hall, do hereby issue this Call for a Mass Meeting to be held at the Pulaski County Courthouse, 45 Third Street NW, Pulaski, VA 24301, in the General District Courtroom (or an alternate site, depending on weather and/or availability), starting at 7:00PM EST on 18 February 2016 for the following purposes:

1. Electing a Chairman, Vice Chairman, Treasurer, and Secretary for the PCRC;
2. Electing the Members of the Pulaski County Republican Committee;
3. Electing up to fifty-five (55) Delegates and an equal number of Alternates to the Republican Party of Virginia 9th Congressional District Convention to be held on Saturday, 09 April 2016 at the George Wythe High School, 1 Maroon Way, Wytheville, VA 24382 or its alternative site, beginning at 10:00AM EDT for the following purposes:
 - a. Electing a 9th Congressional District Republican Committee Chairman;
 - b. Electing delegates and alternates to the Republican National Convention in Cleveland, 18-21 July 2016;
 - c. Electing a presidential elector for the 9th Congressional District Republican Committee;
 - d. Electing RPV State Committee Members representing the 9th Congressional District Republican Committee;
 - e. And for the transaction of such other business as may properly come before the convention;
4. Electing up to fifty-five (55) Delegates and an equal number of Alternates to the Republican Party of Virginia State Convention to be held on 29-30 April 2016 at the James Madison Convocation Center, 895 University Blvd, Harrisonburg, VA 22807 or its alternative site, beginning at 2:30PM EDT on 29 April, and 12:00PM on 30 April, for the following purposes:
 - a. Electing a Republican Party of Virginia Chairman;
 - b. Electing delegates and alternates to the Republican National Convention in Cleveland, 18-21 July 2016;
 - c. Electing presidential electors for the Republican Party of Virginia;
 - d. Electing a Committeeman and Committeewoman to the Republican National Committee;
 - e. And for the transaction of such other business as may properly come before the convention.

Qualifications for Participation

All legal and qualified voters of Pulaski County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

OFFICIAL CALL

Mass Meeting of the Pulaski County Republican Committee of the Republican Party of Virginia

In order to be eligible for election as a Delegate or Alternate to the 9th Congressional District or RPV Conventions, an individual must be registered to vote no later than the pre-filing deadline of Friday, 29 January 2016, at 6:00PM. (In addition, an individual must pre-file for those offices by Friday, 29 January 2016, at 6:00PM.) A person who has made an application for registration and meets all the other requirements herein, but whose name does not appear on the local registration books solely because of the books having been closed in connection with a local election, will nevertheless be deemed a legal and qualified voter.

MILITARY MEMBERS ONLY: Otherwise qualified military members who declare via electronic mail to the Chairman of the Convention or his designee, as specified in the Call for the Convention, that because of the obligations of their official military orders, they are unable to attend their respective Pulaski County Republican Committee mass meeting, canvass or convention called for the purpose of selecting delegates to a Convention, and that in lieu of selecting delegates to represent them from their respective Pulaski County Republican Committee they instead wish to be represented by the Military Delegation, shall be entitled to representation via the Military Delegation.

Filing Requirements

Candidates for the election or nomination at said mass meeting for:

1. Chairman, Vice Chairman, Treasurer, and Secretary of the PCRC;
2. Delegate and Alternate to the 9th Congressional District Convention on 09 April 2016;
3. Delegate and Alternate to the Republican Party of Virginia Convention on 29-30 April 2016;

Shall file a **signed** pre-file form by mail, in electronic form, or in person, to Angie Marshall Hall, 7141 Gate 10 Road, Radford, VA 24141, which must be received not later than 6:00PM EST on Friday, 29 January 2016. (Postmarks do not count or govern.) Forms can be obtained at:
