

**OFFICIAL CALL**  
**Mass Meeting of the Pulaski County Republican Committee**  
**of the Republican Party of Virginia**

As chairman of the Pulaski County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Aaron Smith, do hereby issue this call for a Mass Meeting to be held at the Pulaski County Courthouse, 45 Third Street NW, Pulaski, VA 24301, in the General District Courtroom (or an alternate site, depending on weather and/or availability), starting at 7:00PM ET on 10 August 2017 for the following purposes:

1. Nominating a Republican candidate for the office of Sheriff of Pulaski County to be voted for in the Special Election on 07 November 2017.

Qualifications for Participation

All legal and qualified voters of Pulaski County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

Filing Requirements

Candidates for the election or nomination at said mass meeting shall file a written statement using the attached pre-file form, by mail or in person, to Aaron Smith at 4501 Robinson Tract Rd, Pulaski, VA 24301, which must be received not later than 6:00PM ET on Saturday, 05 August 2017. (Postmarks do not count or govern.) Only those who have pre-filed and paid the indicated filing fee will be considered for nomination at the mass meeting, no other nominations from the floor will be in order. Pre-filed candidates may be required to meet with the Executive Committee prior to the mass meeting date. If the number of persons pre-filing as candidates for election or nomination for all offices to be decided upon by the mass meeting does not meet or exceed the number to be elected or nominated, then the Executive Committee reserves the right to cancel the mass meeting and declare the candidates elected or nominated by the Republican Party or that no candidate shall be elected or nominated.

Registration and Fees

The doors will open at 6:00PM ET, with registration to begin at 6:00PM. There will be no registration fee to attend and/or participate in this Mass Meeting.
