

OFFICIAL CALL

Party Canvass

WASHINGTON COUNTY Republican Committee of the Republican Party of Virginia

As Chairman of the WASHINGTON COUNTY Republican Committee, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, MARYANN COMPTON do hereby issue this call for a Party Canvass to be held at Washington County Republican Headquarters, 1070 W Main St., Suite 6, Abingdon, VA from 11 am to 2 pm local time on MARCH 10, 2018 for the following purposes:

1. To elect a unit chairman, 1st Vice Chair, 2nd Vice Chair, 3rd Vice Chair, Secretary, Treasurer and members to the unit committee;
2. Electing up to 630 Delegates and an equal number of Alternates to the Ninth Congressional District Republican Convention, to be held on Saturday, April 21, 2018 at George Wythe High School, #1 Maroon Way, Wytheville, VA 24382, or its alternate site, beginning at 10:00 a.m. (with registration from 8:30 a.m. to 10:15 a.m.) for the purposes of:
 - a. electing a District Chairman, and
 - b. the transaction of other business as may properly come before the Convention.

Each unit is entitled to one (1) Delegate Vote per 250 Republican votes cast for Governor and President at their last election, so that Washington County is entitled to 126 Delegate Votes;

3. And for the transaction of such other business as may properly come before the mass meeting.

Qualifications for Participation

All legal and qualified voters of Washington County under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party within the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of this writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception thereafter.

Voters may be required to produce personal identification such as a valid photo ID that is acceptable for voting purposes in order to participate.

Filing Requirements

Candidates for election for UNIT CHAIRMAN, 1ST VICE-CHAIRMAN, 2ND VICE-CHAIRMAN, 3RD VICE-CHAIRMAN, TREASURER, SECRETARY, Members of the Washington County Republican Committee, or as a delegate or alternate delegate to the Ninth Congressional District Republican Convention at said party canvass shall file a written statement by mail or in person, to Mary Ann Compton, 14146 Willow Ln. Bristol 24202, which must be received not later than 7 pm on February 22, 2018, and accompanied by any fees required. Postmarks shall not govern.

Candidacy filing fees are as follows:

Unit Chairman – \$50.00 **MANDATORY** Filing Fee

1st Vice Chair - 2nd Vice Chair - 3rd Vice Chair – Secretary - Treasurer – No Fee for these offices

Unit Committee Member – \$25.00 dues for ONE YEAR

Delegate/Alternate Delegate to Ninth District Republican Convention – \$10.00 **MANDATORY** Filing Fee

Please make checks payable to the Washington County Republican Committee.

Uncontested Offices/Cancellation of Party Canvass

If no more than one candidate files for election to any office to be voted upon at the Party Canvass, that candidate will be declared elected. If fewer than the maximum number of unit committee members that Washington County Republican Committee has established pre-file, all properly pre-filed candidates shall be declared elected to the applicable unit committee membership position. If fewer than the maximum number of Delegates that Washington County is entitled to at any District convention pre-file, all properly pre-filed candidates shall be declared elected. **If there are no contested offices to be voted upon at the party canvass, then no party canvass will be held.**

Registration Fees for Party Canvass & Convention

There will be a **voluntary** registration fee of \$5.00 to participate in the Washington County Republican Committee Party Canvass. Please make checks payable to the Washington County Republican Committee.

There is a **MANDATORY** registration fee of \$10.00 for each delegate/alternate delegate elected to the Ninth Congressional District Republican Convention. Fees are requested to be paid at the time of filing for election as a Delegate. Please make checks payable to the Washington County Republican Committee, which will forward the registration fee to the Ninth Congressional District Republican Convention.
