

OFFICIAL CALL

Mass Meeting of the Russell County Committee of the Republican Party of Virginia

As Chairman of the Russell County Committee of the Republican Party, and pursuant to the Plan of Organization and as recommended and directed by the Committee, I, Nate Kiser, do hereby issue this call for a Mass Meeting to be held at the Town of Lebanon Meeting Rooms, Gibson Street, Lebanon, Virginia 24266, at 7:00 pm on Thursday, August 16, 2018 for the following purposes:

*Nominating a Republican candidate for the office of Board of Supervisors to be voted on in the Special Election on November 6, 2018,

*and for the transaction of any other such business that may properly come up before the mass meeting.

Qualifications for Participation All legal and qualified voters of Russell County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

A voter who, subsequent to making a statement of intent, publicly supports a candidate in opposition to a Republican nominee shall not be qualified for participation in party actions as defined in Article I for a period of four (4) years.

In addition to the foregoing, to be in accord with the principles of the Republican Party, unless otherwise stipulated by the appropriate Official Committee, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party with in the last five years.

A single exception to this shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. Any voter that utilizes the foregoing exception, and thereafter participates in the nomination process of a party other than the Republican Party, shall not have the benefit of the exception identified in this paragraph thereafter. Voters shall be required to produce a valid form of photo identification to participate in the Mass Meeting.

Filing Requirements and Registration Fees

Candidates filing for nomination must submitted forms to the County Chairman by 8pm Wednesday August 15th with a \$50 registration fee. Filing forms can be obtained and submitted by contacting the Chairman at 804-317-7869 or RussellCountyVAGOPChairman@gmail.com.

Committee Membership filing will be held from 5:30pm to 7:00pm on Thursday, August 16th.
